AGREED ORDER OF DISMISSAL.

Now come Third-Party Plaintiff Morre-Tec Industries, Inc. (Morre-Tec), by and through counsel, and Third-Party Defendant ICL-IP America Inc. (ICL-IP America), by and through counsel, and hereby represent to the Court that Morre-Tec has agreed to dismiss its third-party claims against ICL-IP America and that the parties mutually agree to dismiss cross-claims had against each other pursuant to the following terms:

- 1) All third-party claims and cross-claims asserted by Morre-Tec and ICL-IP America as against each other in Cindi Greathouse (MLP Case No. 11-C-5350003), Thomas Hatfield (MLP Case No. 11-C-5230015) and Ralph Atwell (MLP Case No. 11-C-5240001) are dismissed without prejudice;
- 2) All third-party claims and cross-claims asserted by Morre-Tec and ICL-IP America as against each other in all West Virginia float-sink actions not specifically referenced above are dismissed with prejudice.

Having considered the foregoing, the Court hereby **ORDERS** that any and all third-party claims, cross-claims and causes of action that Morre-Tec and ICL-IP America have asserted against each other are hereby **DISMISSED** pursuant to the terms outlined herein and stricken from the docket of this Court. Each of the Parties shall bear its respective costs incurred in connection with this matter.




