ORDER

The Presiding Judges have been advised that mediation of all Marcellus Shale Litigation cases, except those cases in which Williams Ohio Valley Midstream, LLC is a Defendant, will be reconvened on October 6-7, 2016. *Order Reconvening Mediation* (Transaction ID 59259111) entered July 11, 2016. Accordingly, the Court **ORDERS** that its detailed, final order granting summary judgment in favor of Defendants in the Harrison County Cherry Camp Trial Group cases pursuant to Rule 54(b) of the West Virginia Rules of Civil Procedure is held in abeyance, pending the outcome of the October 6-7 mediation. The Court further **ORDERS** that all deadlines for the Oxford Road Trial Group and the Halls Run Road Trial Group, including the trial dates previously scheduled in the *Order Designating Oxford Run and Halls Run Road Trial Groups* (Transaction ID 58410156) are hereby stayed pending the outcome of the October 6-7 mediation.
