**DISMISSAL ORDER**

Pending is a joint motion by Liaison Counsel for voluntary dismissal with prejudice of civil actions consolidated before the Mass Litigation Panel (MLP) in which plaintiffs sought damages arising from a chemical contamination incident on January 9, 2014, which affected the water supply in Charleston, West Virginia, and some surrounding communities and counties.<sup>1</sup>

*Joint Motion to Dismiss and Remove Cases from the Court's Docket* (Transaction ID 62467819)

I.

The civil actions consolidated in this proceeding before the Mass Litigation Panel *In Re: Water Contamination Litigation*, Civil Action 16-C-6000, all arise from an interruption in the water supply to Charleston and surrounding areas on January 9, 2014, which resulted from a spill into the Elk River of a chemical mixture, known as MCHM or Crude MCHM, from a facility

owned by Freedom Industries.<sup>2</sup> In the ensuing weeks and months after the event, plaintiffs filed civil actions in both state and federal courts.

Civil actions filed in the United States District Court for the Southern District of West Virginia were consolidated as *Crystal Good, et al. v. American Water Works Company, Inc. et al*, Civil Action No. 2:14-01374.<sup>3</sup> Civil actions filed in state court were removed to federal court, where they were consolidated “for purposes of briefing and resolving the matter of remand”<sup>4</sup> and were ultimately remanded to state court on December 17, 2015.<sup>5</sup> By Administrative Order dated January 28, 2016, the Supreme Court of Appeals of West Virginia referred “all civil actions involving the same or similar common questions of law or fact concerning the chemical leak and water contamination at issue in the above-referenced civil action to the Mass Litigation Panel.”<sup>6</sup>

## II.

The MLP held an initial hearing and established deadlines for the progress of the litigation. Pursuant to the Panel’s order, the plaintiffs filed a consolidated class action complaint, the defendants moved to dismiss and the parties began to engage in discovery. Upon being advised by Liaison Counsel of a tentative class action settlement in the *Crystal Good* action,

negotiated at length between the American Water Defendants and Eastman and both federal class counsel and Liaison Counsel for plaintiffs with cases pending before the MLP, the Panel, by order dated November 3, 2016, granted the parties' joint motion and stayed the MLP proceedings for 90 days based upon the tentative class settlement.<sup>7</sup> This matter has remained stayed pursuant to agreed orders submitted to the Panel by Liaison Counsel while the proposed class settlement proceeded through preliminary and final approval in the United States District Court.<sup>8</sup>

By order dated July 6, 2017, the District Court found that certification of the proposed settlement class was appropriate under Rule 23 of the Federal Rules of Civil Procedure and that the amount and structure of the settlement were generally acceptable. *Good v. W. Virginia-Am. Water Co.*, No. CV 14-1374, 2017 WL 2884535 (S.D.W. Va. July 6, 2017). Although the court concluded "the requirements of both Rule 23(a) and Rule 23(b)(3) are met so that certification of a settlement class as proposed by the parties here is plainly warranted..." *Id.* \*13, it denied the motion without prejudice stating "[t]he court remains particularly concerned by four aspects of the proposed settlement: (1) the tiered compensation structure for certain businesses, (2) the review and "appeals" process when disputes over claims arise, (3) the fixed base payments to certain medical claimants, and (4) the delay of payments pending appellate review."

On August 25, 2017, the parties filed a second joint motion seeking approval of the settlement.<sup>9</sup> By Order dated September 21, 2017, the District Court found "the amended settlement agreement is sufficiently fair, reasonable and adequate such that notice of the amended class settlement should be given as provided in Paragraph 9 of this Order. In making

this determination, the Court has considered the current posture of this litigation and other pending actions and the risks and benefits to the parties involved in both settlement of these claims and continuation of the litigation.” The District Court set a series of deadlines for notice, opt out and objections, and the filing of claims and scheduled a hearing to consider final approval of the settlement on January 9, 2018.

On January 9, 2018, the District Court held the scheduled hearing to consider final approval of the class action settlement. The court took the matter under advisement and continued the hearing until February 1, 2018, at which time the court announced it would enter an order approving the class action settlement.

By order dated June 6, 2018, the United States District Court granted the parties’ joint motion for approval finding the class action settlement to be “fair, reasonable and adequate within the meaning of Fed. R. Civ. P. 23(e).”<sup>10</sup> Thirty days passed and the Panel is advised that no appeals were filed by any party from the order approving the settlement. The class action settlement claims process is therefore proceeding consistent with the approval order.

Throughout the process, the MLP was kept advised by the parties of the progress of the class action settlement. The terms of the settlement state “[o]n the Effective Date, MLP Lead Counsel shall seek dismissal with prejudice of all State Actions except any such action that is brought by an Opt Out.” Amended Class Action Settlement Agreement, MLP Trans. ID 61227188-99 at ¶7.5, p. 53.

The Parties, by Liaison Counsel, now move to voluntarily dismiss those civil actions brought by plaintiffs who did not opt out, object or appeal the class action settlement and are now bound by its terms. A list of cases is attached to this order as Exhibit A. In addition, Plaintiffs by Liaison Counsel, agree to dismissal of claims against defendant Gary Southern,

which are subject to dismissal pursuant to a separate class action settlement approved by the District Court on September 5, 2018. The court is advised that the only plaintiffs with pending civil actions that opted out of the class action settlement are Janet Thompson, Civil Action No. 16-C-123 KAN (*Thompson*), and the Lincoln County Commission, Civil Action No. 17-C-41 LCN (*Lincoln County*). All other civil actions consolidated before the MLP in this matter, according to the parties, are now settled and resolved pursuant to the terms of the Class Action Settlement Agreement, which requires the dismissal of pending actions.

On September 21, 2018, plaintiff Richard Gravely, Civil Action No. 14-C-85 KAN, appeared *pro se* at a status conference for the *Thompson* and *Lincoln County* actions and informed the court he had not received notice of the class action settlement. The court informed Mr. Gravely it had no jurisdiction to address whether he received notice of the class action settlement, and if he did not opt out, his civil action is included in the class action settlement. Nonetheless, on September 26, 2018, Mr. Gravely filed a *Notice of Hearing* (Transaction ID 62492164) regarding the *Joint Motion to Dismiss and Remove Cases from the Court's Docket* (Transaction ID 62467819).

With the exception of the *Thompson* and *Lincoln County* actions, which will remain pending before the Panel, all other civil actions, including Civil Action No. 14-C-85 KAN filed by plaintiff Richard Gravely, are hereby **DISMISSED WITH PREJUDICE**. The Court directs the Clerk of the Circuit Court of Kanawha County to remove all civil actions in *In Re: Water Contamination Litigation*, other than the two civil actions identified above, from the Court's docket.

The Court **FINDS** upon **EXPRESS DETERMINATION** that this is a final order available for the proper application of the appellate process pursuant to Rule 54(b) of the Rules

of Civil Procedure and the Rules of Appellate Procedure. Accordingly, this order is subject to immediate appellate review. The parties are hereby advised: (1) that this is a final order; (2) that any party aggrieved by this order may file an appeal directly to the Supreme Court of Appeals of West Virginia; and (3) that a notice of appeal and the attachments required in the notice of appeal must be filed within thirty (30) days after the entry of this Order, as required by Rule 5(b) of the West Virginia Rules of Appellate Procedure.

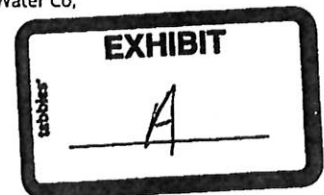
